Magical Farm Horseback Riding Policies:

1. All Students must have approved RIDING helmets~NO bike helmets~ riding boots with $\frac{1}{2}$ "-1" heel, and proper riding pants. No loose baggy clothing. Crocs or any open toed shoe is prohibited.
2. Missed lessons can be made up within 2 weeks of the original lesson date. Kelly Clements must have a notice of cancelling a lesson 24 hours in advance or will automatically forfeit that lesson and any make up. If Kelly Clements cancels, a make up day will be provided.
3. Kelly Clements must receive a 14 day written notice if discontinuing lessons, board, or decreasing lesson frequency.
4. Board, lessons, training, and camp are a set price. There are no carry overs to the next month, or deductions for missed lessons. Tuition is due for every month.
5. Tuition and board are due the 1st of every month. If received after the first of the month a \$50 late fee will apply along with \$10 fee for every day late after the first. No exceptions. Check, cash, Venmo, or PayPal are forms of payment.
6. Lessons are very rarely cancelled. Barn Lessons and trail rides are still lessons and are very vital to learning proper horsemanship. If you choose not to participate in a trail or barn lesson in bad weather, the lesson will be forfeited.
7. If your child is ill, or there is an emergency, please let us know asap and we will schedule a make up lesson. We must be notified before lesson time. Please not at lesson time.
8. Kelly Clements must pre approve all visitors to the barn. Family and friends must have proper footwear and a helmet(if under 18) to be around horses. No dogs or other pets are allowed without approval.
9. All students are required to clean up after themselves and horses at every lesson. Please scoop your poop in the tack up areas and clean any tack used.

10. Students, family members, and visitors are not permitted to handle, approach, or be in any area with farm animals or horses without direct supervision and explicit permission from Kelly Clements.

I/We, give consent of Kelly Clements to seek medical attention for my child or me. (If parent, guardian, or emergency contact can not be reached)

I/We do not hold Kelly Clements, the Clements Family or any of its employees or representatives liable for any bodily injury or death that occurs on Kelly Clements Farm premises, or at any other location or transportation to thereof.
